

Minutes of the meeting:

The meeting of the IQAC, Imphal College held on 12/07/2016 at 1.00 pm in the Office Chamber of Principal, Imphal College was chaired by Dr. Ng. Ibotombi Singh, Chairman/Principal, Imphal College in presence of above signed members of IQAC, Imphal College. After minute discussion on the agenda listed the following resolutions are adopted unanimously.

1. In connection with the expansion of Imphal-Tiddim Road highway Imphal college canteen located adjacent to Central Library was demolished and since then students and teachers are facing numerous inconveniences. Directorate of University & Higher Education, Government of Manipur, may not be in a position to provide funds for construction of canteen in near future. Prior to the PTV for 2nd Cycle NAAC Assessment it is essential to have a canteen in the college premises, in this connection incumbent Member of Parliament, Dr. Th. Meinya, who is a former faculty in Mathematics department may be requested to provide funds from his MPLADF for the same purpose.
2. With the completion of Imphal College swimming pool and handing over the same to the college authority, a management committee shall be established and look out the ways and means for utilization and management of the same in a productive manner. This meeting empowers the committee to arrive an understanding with renowned sports organization/club which has manpower, capacity and expertise for good maintenance and conducting swimming classes in the off hours of the college students. Committee is also entrusted to generate revenue under some terms and conditions that does not infringe with the objective of UGC concerning the facility.
3. With attainment of optimum functional objectives of Imphal College Bio-Tech Hub, its benefits may be extended to schools and colleges located in the close proximity of Imphal college. In this regard a series of invited extension lectures with resource persons from reputed central and state government institutes will be conducted. Dr.G C Bag shall be appointed as Nodal Officer for systematic and proper arrangement for conducting lecture series and hands-on training programmes.
4. All teaching and non-teaching staff of Imphal College shall put extra effort for securing better NAAC score in the forthcoming 2nd Cycle NAAC Assessment. If required voluntary contributions from the faculty members shall be made without any reservation in the interest of Imphal College.
